My Quorum Pipeline allows users from interstate & intrastate pipelines as well as LDCs to quickly adapt to changing market conditions with automated processes and access to real-time data for real-time decision making. The application's nomination, allocations, and invoicing modules can support any size asset by allowing users to configure each module to fit the asset's business requirements. My Quorum Pipeline is also NAESB certified and kept up-to-date with the latest regulatory standards as they are made available.

Software License Options and Metrics

This document defines the Standard Functionality and Add-Ons together with applicable license metrics that are available for Customer's access under mutually agreed My Quorum Pipeline Self-Hosted Subscription Order(s). Such Order(s) shall specify the selected Add-On(s) and authorized license metric quantity.

Description of My Quorum Pipeline Standard Functionality

My Quorum Pipeline Standard Functionality

The Pipeline Standard Functionality is the foundation of the My Quorum Pipeline software and includes functionalities to drive efficiency, improve decision-making, and reduce risk with access to real-time data for real-time decision making.

The Standard Functionality focus on requirements for the External Scheduler, External Operator and Pipeline Internal personas which including the following:

- Pipeline Administration
- Contracts
- Nominations
- Confirmations
- Allocations
- Invoicing
- Regulatory Compliance

My Quorum Pipeline Add-Ons

Several Add-Ons for the My Quorum Pipeline Software are available, and they can be separately licensed in addition to the My Quorum Pipeline Standard Functionality.

The following Add-Ons are currently available for My Quorum Pipeline:

- **Contract Management (QCM):** Create and manage contracts for transportation, storage, marketing and gathering contracts.
- **Query Module (QQM):** Business objects, ad-hoc query tool for use with My Quorum products.

- **Quorum Gas Marketing (QGM):** Comprehensive end-to-end deal capture, scheduling, and accounting capabilities for gas marketing. If QGM is a selected add-on, QCM must be selected as well. These two products must be sold together.
- **Informational Posting Website (IPWS):** NAESB compliant postings website for information related to regulated pipelines.
- **Capacity Release:** NASEB compliant module for releasing capacity on firm contracts.
- **Request for Service:** Module for requesting and approving new contracts and contract amendments.
- **Lease Nominations:** Module for creating lease nominations based on a configurable set of rules
- **Capacity Allocation Scheduling:** Module for classifying nominations based on a configurable set of rules and performing capacity cuts based on classifications
- **Billing Configuration (for LDC):** Configurable invoicing module for LDC customers
- **Choice Enrollment (LDC):** Module for enrolling meters for LDC customers
- **Electronic Data Interface (EDI):** Module for sending and receiving NAESB compliant EDI files to trading partners

General My Quorum Pipeline Licensing Terms

The My Quorum Pipeline Software is licensed separately for the Standard Functionality and each Add-On according to the licensing scheme described in the Agreement and the Order (including this Product Supplement). Unless otherwise stated, a pre-requisite for licensing and implementing Add-Ons is that the My Quorum Pipeline Standard Functionality is licensed and properly installed.

Subject to the terms of the Order, an My Quorum Pipeline Software Subscription entitles Customer to receive access to the Standard Functionality and selected My Quorum Pipeline Add-On(s) in connection with and for the benefit of the authorized Number of Licenses, Permitted Users and Territory of Use (“License Metrics”) as applicable and defined in the Order.

The Standard Functionality and Add-Ons are licensed under a scheme where the following metrics are used to determine the annual Subscription Fee(s).

The Standard Functionality, selected Add-On(s) and the applicable initial License Metrics are identified in the Order together with any special terms agreed between the Parties.

Changes to Metrics

Renewal Terms: Before each renewal term, the Vendor is permitted to access and review Customer's usage information (including Number of Licenses, Permitted Users and Territory of Use) for the previous twelve months to determine the Fees for the next renewal term.

Exceeding License Metrics: The Licensed Materials may be used for no more than the License Metrics. Additional entitlements must be paid in the event usage exceeds the License Metrics, at the pricing in effect at the time the additional entitlement is added.

Increasing License Metrics During a Subscription Term: When increasing the License Metrics level during an ongoing Subscription Term, the difference in Subscription Fee(s) is calculated at the year of the increase and an additional Subscription Fee will apply as of the triggering event until the remainder of the ongoing 12-months period and will be invoiced in full the month after setting the higher License Metrics level. Thereafter, the applicable Subscription Fee(s) are again invoiced annually in advance for each annually recurring 12-months during the committed Subscription Term.

No Decreases to License Metrics During a Subscription Term: Customer may not decrease the Licensed Metrics during the initial, committed and/or an ongoing Subscription Term.

Delivery of the Software: The Software Subscription(s) will be delivered to the Customer on or before the License start date specified in the Order. Delivery shall be deemed to occur upon the Software being made available to the Customer, including but not limited to the physical delivery of media, provision of a download link, provision of login credentials, the issuance of license keys or any other means by which the Software is made available to the Customer. If access to the Software includes access to Module(s) or Add-On(s) of the product suite for which Customer has not procured a Subscription, Customer is not entitled to extend the use of the Software to such additional Module(s) or Add-On(s) without procurement of additional Subscription(s).
