### 11 Ways Track Differs From Your T&A System

- 1 TRACK is designed to do both real-time capture of daily badge events and provide automated contract terms, conditions, schedule, rate comparison and correction to eliminate errors.
- 2 TRACK is available with a Virtual Gate Mobile application for capturing badge events in remote locations without gate access systems.
- 3 TRACK collects badge events from your access control systems, compares those events with that contractor's actual contract terms and conditions and enables you to pay the allowable rates based on types of contractors and agreements.
- 4 TRACK provides visibility to daily costs and work schedule to enable a change of course when needed to prevent cost or schedule overruns.
- 5 TRACK is used daily to report on crew mix, work progress, actual costs vs budget and more.
