Background

Trax Credit Union is a not-for-profit financial institution headquartered in Tampa, Florida, servicing Hillsborough, Polk and Pasco Counties. Trax, formerly known as Railroad & Industrial Credit Union was founded in 1935 and today has over 41,000 members and manages over \$440 million in assets and operates out of nine branches. Trax focuses on providing financial services excellence to underserved areas throughout the state of Florida.

Following a year-end internal audit, the organization realized that a substantial amount of time and resources were being allocated toward addressing phishing and counterfeit websites. In order to protect their customers' digital transactions and prevent fraudulent activities, Trax required a comprehensive digital threat protection solution that was able to provide strong security without negatively impacting their business or the customer experience.

Challenges and Requirements

Trax had been faced with an increasing number of fraud cases, specifically counterfeit websites and phishing attempts that aimed to trick their customers in providing sensitive account information.
